# **During-reading questions**

### CHAPTER ONE

3 The police share that Matthew Mackie is a doctor who retired from medicine and was never a priest. The Murder Club tell the police about the bones. They also share that they are happy that Jason did not kill Tony Curran, and that Turkish Johnny took the photo taken in the Black Bridge.

## CHAPTER TEN

- 1 Peter Ward is Bobby Tanner. Elizabeth found him by watching the CCTV of the Woodvale Cemetery where his brother is buried. She noticed a florist's van with Peter Ward's name, address and telephone number parked there on the date of his brother's birthday and the date of his death.
- 2 He met a gang from Liverpool, and they bought and used a florist's business to smuggle drugs into the UK along with the flowers in the lorries. Later, after the police had caught the other gang members, Peter had made some money and realized he had learned a lot about flowers. So he started his own florist's in Folkestone.
- **3** They know Peter Ward is not a suspect because he has CCTV of himself in his florist's shop on the day of the murder.

## CHAPTER ELEVEN

- 1 They decide to meet someone who will know if Turkish Johnny came back to the UK when Curran was murdered.
- **2** Reader's own answer. **Model answer:** She didn't rise above Detective Inspector because she probably argued with important male police officers who wanted to stop her career because she was strong and female.

#### CHAPTER TWELVE

- 1 She has learned that a company called Bramley Holdings has bought Coopers Chase.
- **2** It means "you will have to kill me before I let you do that".
- **3** Reader's own answer. **Model answer:** She is trying to get Mackie to confess by telling him a story that he recognizes about himself. By telling him this story, she is letting him know that she knows what he has done.

#### CHAPTER THIRTEEN

- 1 She is "Maggie", the woman that Matthew Mackie loved. They had a relationship, and she realized she was expecting a baby. She killed herself when Sister Mary found out about it. Mackie asked for "Maggie" to be buried in the cemetery in return for staying silent about what happened.
- **2** Ian Ventham was planning to dig up the cemetery where Maggie is buried. This gave Mackie a very good reason for wanting him dead.
- 3 He arranges to meet her on a dating app because he wants to accuse her of Ian Ventham's murder. Yes, it is a successful meeting because they enjoy their lunch and being with each other, but Jason soon realizes that Karen is not the murderer.

- 2 The police think he went to Cyprus because, after helping Bogdan to kill Turkish Johnny, Steve Ercan flew to Cyprus, using Johnny's passport, and then came back, using his own. Steve and Bogdan also took clothes and money from Johnny's flat to make it look like he had decided to leave.
- **3** Elizabeth starts to cry because she is sad about Penny and John, and worried for Stephen's health.

# CHAPTER SIXTEEN

- 1 Reader's own answer. Model answer: Elizabeth didn't go to the funeral because she was too upset about her friend's death or did not agree with what she did (or perhaps both).
- 2 Bramley Holdings, a company owned by Joyce's daughter Joanna, bought Coopers Chase. Joanna has seen how happy her mother is at Coopers Chase and does not want things to change for her. Joanna also knows her company will make a lot of money from Coopers Chase and the Hillcrest development.
- **3** Reader's own answer. **Model answer:** The note could be news about another murder.
